2. I am fully aware that all intoxicants, narcotic drugs, materials and publications that violate public morals and all publications that affect any religious beliefs or any political trends and conflict with the Islamic religion are prohibited from entering the Kingdom.

I have never been deported from the Kingdom of Saudi Arabia or any country in the Gulf .4 .Cooperation Council, or violated its regulations

I pledge to adhere to the type, conditions, and duration of the visa granted to me and to .5 leave the Kingdom before the expiry of the period of stay specified in the entry visa. I am also fully aware that my violation of the regulations in force in the Kingdom or my committing one of the prohibitions mentioned above or those written on the entry visa will expose me to punishment and the application of the penalties stipulated It must regulate the treatment of those coming to the Kingdom with entry visas for Hajj or Umrah and others issued by Royal Decree No. (M/42) dated 10/18/1404 AH, as well as the penalties for violators of the residency and work regulations issued pursuant to .Council of Ministers Resolution No. (140) dated 5/6/1434 AH

I acknowledge the right of the Saudi authorities to return me from the port of entry on .6 my own account or to deport me from the territory of the Kingdom after my entry into it, and to apply to me the penalties stipulated by law if it is proven at any time after obtaining the visa or residence permit that I have submitted incorrect papers or documents. Or making false statements to any competent Saudi authority at home or abroad with the intention of obtaining for myself or another person an entry or residence permit or any official visa, or whether I was a contributor or partner in .providing this information or documents contrary to the truth and reality

I acknowledge with knowledge that the penalty for smuggling drugs into the Kingdom .7 .or promoting them within it is death

I pledge to declare amounts of cash or precious metals and the like whose value .8 reaches (60,000) sixty thousand riyals or more, or their equivalent in foreign currencies, during my arrival to or departure from the Kingdom. I also pledge to declare any valuable luggage with me. When I come to the Kingdom and am willing to pay the customs duties and taxes due on it, and if I violate that, it exposes me to legal accountability and the application of what the Kingdom's regulations stipulate against .me

I acknowledge that the laws in the Kingdom criminalize the payment of any bribe .9 amount, regardless of its amount, and it is considered a criminal case that exposes its .practitioner to imprisonment, a fine, or both

I acknowledge and pledge again that all the information I have written down is correct .10 and I bear full responsibility for it. If it is proven otherwise - or it becomes clear that I am on the banned list - my application will be rejected, my visa will be automatically canceled if I obtain it, or I will not be allowed to enter the Kingdom. Saudi Arabia if I have a valid visa, and I acknowledge the right of the Saudi authorities to return me from .the port of entry at my own expense and I do not have the right to claim compensation
